* Any book you grant awards to can also be nominated for the new **"Step Beyond" Award**. For that the entire book must be judged, regardless of whether or not only part of the book was considered for the special or project area awards. The score must be at least 120 out of 130 points.

 B. 4-H Activities & Awards Pages: Completely filled out for all years in 4-H. Save form from year to year. 	10		
 C. Community Services Page: Accurately describes all citizenship or community service activities member participated in as part of 4-H. Includes full description including date. Done neatly, includes captioned photos and/or clippings. 	20		
 D. My 4-H Year - A 4-H Story: Goes a step beyond the "who, what, when" on projects, leadership, comm. service and activities, telling the why and how: what was enjoyed, life skills learned or improved on, personal growth, etc. Avoids repeating information contained elsewhere in record book. Uses captioned pictures or clippings to tell of member involvement in club, and at county, state, and national levels. 	20		
 E. Project Pages: (Section dividers for each project required): Completed project page for each project listed in Activities section. Included additional pages containing pictures or drawings to show member working on project. Pictures/drawings must be captioned. Does not include project literature, certificates, ribbons, etc. Project Content / Worth Does record show evidence of goal setting 	20		
and meeting goals?Does it have a thorough list of expenses for	5		
the project?Does it identify accomplishments achieved in the project?	5

G. General / Project Leader Comment	5	General/Project Leader comments and signature are required .
 H. NEATNESS & COMPLETENESS: This includes general appearance such as using a pencil or the same color ink throughout the record. If using a computer, must be used throughout. Includes only information from the current 4-H year. Uses section dividers throughout the record. All blanks completed. If information is not available, insert "NA." NOTE TO JUDGE: Consider age and ability. 	20
