

2020 Green Lake Fairest of the Fair Eligibility Requirements

1. Contestant(s) must be eighteen (18) years of age as of January 1, 2020 and cannot be over 25 years of age as of August 4, 2019.
2. Contestant(s) must make individual arrangements, or have the ability to make individual arrangements for transportation adequate to meet position responsibilities and essential position functions.
3. Contestant(s) must be a resident of Green Lake County or youth enrolled in a Green Lake County or Rip-on youth organization approved by the Fair.
4. Contestant(s) must be available to attend 5 community events (listed below), all 4 days of the Green Lake County Fair (July 30-August 2, 2020-*subject to change*), the 2020 Green Lake County Fairest of the Fair coronation ceremony, and fulfill all duties of the position.
5. Harvest Festival, Green Lake - September 28 & 29, 2019 (*dates needs to be finalized*)
6. Markesan June Dairy Days Parade 2020 - TBA
7. Dairy Breakfast 2020 - TBA
8. 4th of July Celebrations/Parades 2020 - TBA
9. The contestant(s) agrees that the time, method, and manner of judging shall be solely within the discretion of the rules and regulations set forth by the Fair Promotions Committee and the Wisconsin Association of the Fairs and that the decision of the judges shall be final.
10. If I am named as the Green Lake County Fairest of the Fair, and for any reason do not fulfill the duties of this position for the entire one year term, I will forfeit all scholarship monies and other prizes that are awarded with the position. All of the scholarship monies and other prizes will be returned to the Fair Promotions Committee.
11. Contestants will be required to dress in business or professional attire, accompanied by the sash and crown, as well as act in a business professional manner, while on duty promoting and representing the Green Lake County Fair. Dresses should be knee length, no plunging necklines, shoulders covered. Fair dress code must be appropriate for events attending. For example, boots/close-toed shoes, jeans, and a shirt can be worn for livestock shows.
12. If I am named as the 2020 Green Lake County Fairest of the Fair, I will compete in the Wisconsin State Fairest of the Fairs competition January 2020.
13. If I am named as the Green Lake County Fairest of the Fair I will NOT consume alcohol or use tobacco products while on official duty representing the Green Lake County Fair.
14. The individual(s) selected as Green Lake County Fairest of the Fair will not be eligible to compete in future Green Lake County Fairest of the Fair competitions.
15. Applicants need to have a strong appreciation for the Fair, but are not required to have exhibited at the Fair.

If I do not abide by these rules, I understand that the first runner-up will become eligible to be named the Green Lake County Fairest of the Fair per the Fair Promotions Committee and Green Lake County Agriculture, Extension Education & Fair Committee.
