

To: Individuals Desiring Private Pesticide Applicator Training and Certification

Our records show that your pesticide applicator certification has expired in 2019 or will expire in 2020. Please check your certification card for the exact date of expiration. You must re-certify if you desire to continue to use restricted-use pesticides.

The dates for the pesticide applicator training sessions for private applicators in Green Lake County are **Wednesday, January 15, 2020 and Wednesday, February 19, 2020**. The training sessions will be held in the Training Room at the Green Lake County Government Center.

Training will be held from 9:00 a.m. to noon. Lunch will be provided from 12:00 to 12:30. The exams for certification will be given from 12:30 to 2:30. Registration should be completed as soon as possible at the Green Lake County Extension office. Cost of registration which includes the training manual and lunch, is \$35 per individual.

Producers may attend a training session at the Green Lake County location or at a neighboring county if it is more convenient. Locations and dates for county pesticide applicator trainings will be listed on the following websites:

You should register at the location where you will take the exam. You must register at the Extension Office at least one week prior to the exam date or earlier. The Extension Office hours are Monday through Friday, 8:00 am -4:30 pm.

Please note that in April 1998, the Wisconsin legislature passed into law ACT 191. This law requires persons and businesses seeking various Wisconsin state certifications or licenses to submit personal information such as their social security number (SSN) on their applications. The Department of Agriculture Trade and Consumer Protection (DATCP) may not disclose the SSN to anyone other than the Department of Workforce Development. Private pesticide applicator certifications are included in ACT 191.

Also, please note that DATCP now requires that all persons wishing to take the private or commercial pesticide applicator certification exam present proof of identification (a photo ID) at the time the examination is taken. Please bring the proper documentation (your SSN and a photo ID) and a hand held calculator with you to the exam site the day of training.
