HOW TO ENTER IN THE FAIR



The Green Lake County Fair online entries will be open June 1 through July 1 at 11:59 p.m. To enter online, please follow the steps below:

- Access Blue Ribbon Fair Online through the Green Lake County Extension Fair website (greenlake. extension.wisc.edu/fair).
- 2. ALL exhibitors need to create a NEW ACCOUNT EVERY YEAR. After account is created, you will receive an email confirmation. The Fair Office will also receive an e-mail. At this time, entry selections can be made and you may access the system at any time (up to the termination/deadline date) with your log-in information.
- 3. Now begin selecting entries. Please make note that Junior Class Departments are listed first, followed by Open Class Departments. Once you have selected a Department, you may expand the Class letter by clicking on the plus symbol. This enables you to view all Lot numbers and select the appropriate one(s).
- 4. After selecting your entries, please recheck your list and click <u>SUBMIT</u>. <u>The process is not complete until this step has been made</u>. Every time you submit an entry, the system will send you and the Fair Office an e-mail confirmation of your submitted entry. <u>If you do not receive a confirmation e-mail within ONE day, contact the Fair Office immediately at 920.294.4032.</u>
- 5. You may sign in and log off as many times as you'd like during the activation period. Even if you submit your entry and realize you have forgotten an entry, you may log back in, add en-

- try and <u>SUBMIT</u> again. You will then receive another e-mail confirmation.
- 6. REMEMBER: Exhibitor must receive at least TWO E-MAIL CONFIRMATIONS for entry to be valid. One e-mail confirmation for creating an account and another e-mail confirmation each time you submit an entry.

JUNIOR HORSE EXHIBITORS – Please make note that you must identify all classes you wish to enter. However, **YOU MUST DESIGNATE TWO LOTS** in which you will be receiving premiums. Please send an e-mail to the Fair Office at fair@co.green-lake.wi.us stating that you just submitted your Entry Form and specify in the e-mail the two premium lots. If no premium lots are specified by the entry deadline date, **NO PREMIUMS** WILL BE PAID.

No changes or additions will be allowed after entry deadline date of July 1 at 11:59 pm. No appeals to any Committee will be allowed.

The online software and entry tags do not provide exhibitors the specific requirements tailored to certain Departments. 

GENERAL RULES, REGULATIONS & CODE OF CONDUCT

- Only residents of Green Lake County or youth enrolled in a Green Lake County or Ripon youth organization approved by the Fair are eligible as exhibitors (please refer to Department 17-Class B for an exception to this rule). Eligible Open Class exhibitors also include Green Lake County Home & Community Education (HCE) members, Green Lake County 4-H members' parents and adults affiliated with a recognized Green Lake County organization. The item exhibited must have been completed since the prior year's Fair.
- 2. All references to the exhibitor's age and grade is as of January 1st of the calendar year. All individuals (4-H, FFA, etc.) that are 8-19 years of age AND 3rd grade-one year past high school, as of January 1st, are allowed to exhibit in the Junior Division if they belong to a county recognized youth group. The only exception to age is for those individuals enrolled in the 4-H Cloverbud Project. Exhibitors must be at least 8 years of age and in the 3rd grade, as of January 1st, to exhibit animals in any Junior or Open Division Department. Exhibitors must be at least 8 years of age and in the 3rd grade, as of January 1st, to exhibit in the Open Division. Entries will not be accepted from individuals who do not supply age and/or grade information.
- All exhibitor entries must be turned into or received by the Fair Office on or before July 1, 2020 by 4:00 p.m. Please note that there will be absolutely <u>NO CHANGES/ADDITIONS</u> or <u>LATE ENTRIES</u> allowed after this date. FAXED ENTRIES WILL NOT BE ACCEPTED.
- 4. There is no exhibitor entry fee charged in any department.
- Educational Club Booths can be constructed on the Friday before the fair (8:00 am to 4:30 pm) and Monday of fair week (8:00 am to 4:30 pm). All booths must be completed by 4:30 pm on Monday.
- The leader of each club or organization will be responsible for their organization for certifying that members are in good standing when entries are made.
- 7. Entry tags must be securely fastened to the exhibit. Claim checks are required for release of entries at the close of the Fair.
- 8. Entry tags contain limited descriptions. Please refer to the Premium book for complete description pertaining to your exhibit.

- All sheep and goats must have an official scrapies ear tag. Sheep and goats are not allowed to be removed from the trailer until the Sheep Superintendent verifies that an official scrapie ear tag is present.
- 10. Each project animal is expected to be in excellent health and condition while at the Fair. Animals in need of ongoing veterinary care and those who do not properly represent their breed and species will be asked to leave the Fair.
- 11. Exhibitors will treat animals in a humane manner and provide appropriate animal care and management.
- 12. YQCA Certifications: All Dairy, Beef, Sheep, Swine, Goat, Poultry & Rabbit exhibitors must complete the Youth for the Quality Care of Animals (YQCA) training each year to be eligible to exhibit their animal(s) at the Green Lake County Fair. Exhibitors must attend one scheduled YQCA training announced by 4-H or FFA in early spring or complete the training online. The YQCA certification must be completed by July 1.
- 13. No exhibitors will be allowed to stay overnight in the barns.
- 14. Livestock exhibitors will furnish their own feed and bedding and care for their animals. Sawdust will not be provided by the fair. It is recommended that exhibitors bring bagged sawdust. All animal exhibitors not providing proper feeding, cleaning and care, will receive one warning notice from the superintendent. If the issue has not been addressed in a timely manner, a second notice will be issued from the Youth Exhibit Committee Chair. If the issue has not been addressed in a timely manner after the second notice, the exhibitor will forfeit premiums and will be issued a one year suspension from exhibiting animals at the Green Lake County Fair.
- 15. All decisions of the judge are final. Any exhibitor, parent, or spectator who shall attempt to interfere with the deliberations or decisions of the judge, will be excluded from competition in that class and forfeit all rights to premiums. All exhibitors and adults are expected to treat judges with respect. Anyone is welcome to discuss with the judge ways to improve their project or their showing skills after the completion of the show. It is not appropriate to harass or argue with the judge. If the judge files a written complaint to the Fair Committee, that individual will not be allowed to participate or attend the

- judging competition or show the following year for that department.
- 16. All animals going to slaughter will be released at 3:00 p.m. on Sunday. All other animals/non-animal projects will not be released until 5:00 p.m. on Sunday. There are no exceptions. Exhibits not picked up at the close of the Fair will be at the Green Lake County Government Center-Training Room for exhibitors to pickup.
- 17. There shall be no signs posted in any Fair buildings, other than those approved and posted by the order of the Fair Management. The exhibitor may display official entry tags, identification cards and ribbons.
- 18. No exhibitor shall wear clothing that bears commercial advertising when competing before the judge in any event.
- 19. All individuals/organizations/businesses renting or leasing space for commercial exhibits or any other special privileges will be required to pay for them in advance. Exhibits must be in place by 8:00 a.m. on Thursday and remain until Sunday at 4:00 p.m.
- 20. Green Lake County, the Agriculture, Extension Education & Fair Committee, Agriculture Agent, Family Living Educator, Community Resource Development Educator, 4-H Youth Development Educator, FFA Advisors, Youth Exhibit Committee, and Green Lake County Board of Supervisors, their agents or employees shall not be liable for any property damages or loss due to personal injury of Fair visitors or exhibitors.
- 21. General supervision of the grounds and exhibitors is vested in the Fair Committee who shall see that order is maintained. Exhibitors will be held responsible for any damage or accident, which may be caused by their entries. It is further understood that Green Lake County can only accept responsibility for damages when legally liable due to negligent acts of county officials and/or employees.
- 22. The Green Lake County Fair reserves the final and absolute right to interpret these rules and resolutions and arbitrarily settle and determine all matters, questions and difference in regard hereto, or otherwise rising out of, connected with or incident to the Fair.
- 23. All Green Lake County Junior and Open Class premiums paid out to exhibitors must be cashed within 60 days of the date issued on the check. After 60 days have expired, the check is void and will not be reissued.
- 24. Recipients of donated awards will be selected by the judge of that department in which the award is donated.

- 25. Any exhibitor who violates fair rules, or is guilty of misconduct such as the possession and/or use of alcohol or drugs during the Fair, will be disqualified from competition and forfeit all premiums at the discretion of the Fair Committee.
- Exhibitors are expected to refrain from gambling, sexual misconduct and objectionable language (including swearing).
- 27. All fair exhibitors may enter only one exhibit per premium or lot number in the Junior and Open Divisions.
- 28. If a substitution is allowed, it may be made only within that department and division. The Department Superintendent will make the final decision as to whether a substitution will be allowed prior to judging.
- 29. All exhibitors have the responsibility of showing their own exhibits in individual conference judging. THE ONLY EXCEPTION TO THIS RULE is sickness, injury or death in the immediate family. The Youth Exhibit Committee will make the final determination. If other activities such as camp, vacation, school activities, job. or skill lessons will interfere with the exhibitor showing their own exhibits, the exhibitor should consider entering the project in Open Class, or making changes in their schedule to accommodate attendance at the fair with their project. Individual conference judging is an important aspect of the 4-H and youth project areas and it is important that the exhibitors show their own exhibit.
- 30. If an exhibitor or exhibitor's entry is in question due to misrepresentation, validity of ownership or management, the same item was exhibited at previous fairs, or any other violation of rules, the person questioning will take their concern in writing to the Youth Exhibit Committee and the members will make the final decision. If the Youth Exhibit Committee determines the exhibitor to be in violation, the exhibitor will be disqualified.
- 31. No private "for sale" or advertising signs may be posted in the Junior or Open Class exhibit areas, unless pre-approved by the Fair Committee (with the exception of rabbits and poultry). Sign may only be the size of a postcard.
- 32. Parents and exhibitors are required to attend mandatory educational sessions that are scheduled. Failure to attend such sessions will result in the disqualification of the exhibitor in that department.
- 33. Premiums will be mailed to the exhibitors as soon as they are processed. Because premiums are funded through WDATCP and with the uncertain state budget situation, premiums stated in the Fair Book (Premium List) may be reduced or eliminated.

- 33. Respect of Self: Self-respect is most important. It is extremely difficult to respect others if you don't respect yourself. Respecting yourself includes good personal grooming, neatness and cleanliness (pertaining to your person and immediate personal surroundings). Respect for Adults: Respect for adults reflects a willingness and choice to learn from their knowledge and wider experiences. Respect of Children: Children deserve respect that comes with patience and understanding of their special needs. Respect of Peers: Peer respect means choosing to treat people with whom you associate with fairly and with dignity. Respect of Property: The word property covers many things. Respect means choosing to use another's property with permission and handling it with care while in your possession. Respect of Country: Recognizing our country's symbols like the flag, national anthem, etc. is a way of demonstrating respect.
- 35. Personal Grooming and Dress: During judging you are expected to use good judgment in selecting appropriate clothing to wear. It is an expectation that you wear clothing that fits properly, is neat and is not revealing as to cause a distraction. For safety reasons, shoes must be worn. Clothing or articles displaying

- obscenities, suggestive slogans and/or images, nudity, gangs, crime, violence, occult worship, slanderous or harassing, encourages disruptive behavior. You should have no skin exposed from mid-thigh to the armpit line. Undergarments are to be completely covered at all times. Muscle shirts, spaghetti straps, tank tops, seethrough clothing, bare midriffs, torn or ripped clothing, chains, strapless and/or backless outfits, spandex and beachwear should not be worn. If you choose to dress inappropriately, the 4-H Program Coordinator will ask you to correct the problem by changing clothes.
- 36. Exhibitors violating any of the above will be subject to any or all of the following consequences.
 - Notification of emergency personnel if there is reason to believe it is necessary.
 - Notification of parents or guardians.
 - Individual may be required to appear before the Green Lake County Fair Committee to explain his/her actions
 - Removal of individual and his/her exhibits from the present year's Junior Fair. Any premiums earned will be revoked.
 - Revocation of privilege to enter exhibits in future Green Lake County Fairs.

CHAPTER ATCP 160 DISTRICT & COUNTY FAIRS

Subchapter I - GENERAL REQUIREMENTS AND DEFINITIONS

ATCP 160.01 DEFINITIONS. As used in this chapter:

- (1) "Breed class" and "breeding class" mean a specific breed within a class such as Holstein in the dairy class.
- (2) "Class" means a grouping in which exhibits may be entered, including an animal breed or age group for animal exhibits; a type of produce, crop or food; or a specific age, age group or educational grade level of exhibitor.
- (3) "Danish judging system" means a judging system that allows for multiple first, second, third and fourth class selections as provided in s.ATCP 160.91 (4)(b).
- (4) "Department" as it relates to the organizational structure of a fair, means an animal species, production group, or other principal classification of exhibits. As used in any other context, "department" means the state of Wisconsin Department of Agriculture, Trade and Consumer Protection.
- (5) "Division" means one of 3 exhibitor group classifica-tions for a fair and is limited to junior division, open division and senior citizens division.

- (6) "Entry class" means a class in which the fair allows exhibitors to submit entries.
- (7) "Exotic domestic animal" means an animal that is not a common farm animal.
- (8) "Lot" or "lot number" means the numerical designation assigned by a local fair for a specific category of exhibits within a class.
- (9) "Market class" means a class that includes animals of a certain weight for the breed class that can be sold for slaughter.
- (10) "Premium" means a monetary prize that a county or district fair awards to an exhibitor after judging all competing exhibits in the class to which the premium pertains.
- (11) "Regular judging system" means a judging system that allows for one first, second, third and fourth class selection as provided in s.ATCP 160.91 (4)(c)
- (12) "Self determined project" means a project that meets all of the following criteria:
 - (a) It is approved by the fair board.
 - (b) Its subject matter is related to any of the junior fair department 9, 10, 13 to 16, 18 or 20 to 29.

- (c) It does not fall into a defined entry class within any department.
- (d) It is carried out by a 4-H member enrolled in a designated 4-H project or alternative project that follows 4-H guidelines, or by a member of another youth organization that does equivalent work.

ATCP 160.02 PREMIUM REQUIREMENTS. (1) General.

- (a) The state aid authorized by s. 93.23(1), Stats.,
- may be paid only on net premiums, which consist of total premiums paid less total entry fees received. The department may withhold state premium aid from any fair, which does not enforce the animal health provisions required under ch. ATCP 10 for all classes of livestock exhibited at the fair. State aid will be paid only on premiums actually paid by bank check or draft.
- (b) No deductions may be made from premium money won by an exhibitor. Premiums may, however, be withheld where exhibition rules established by the fair association are violated. A written statement of violation shall be submitted to the department to justify action taken by a local fair.
- (c) Premiums offered shall be definite in amount. No decrease or increase in published premiums may be made because of the financial condition or the organization or for any other reason.
- (d) State aid may be paid on no more than 2 premiums awarded an exhibitor under one premium or lot number in open division individual livestock classes, except poultry and rabbits, and no more than one premium in all other classes, including poultry and rabbits.
- (e) No county or district fair may receive state aid for a premium awarded to any exhibitor in the open division if that exhibitor entered the same exhibit in the junior division at the same county or district fair. This paragraph does not apply if the exhibit was entered in the junior division only as part of a herd group, carcass class or performance class.
- (f) No state aid will be paid on the cost of ribbons, cups, trophy prizes or entertainment contests.

(2) Premium Lists.

- (a) Premiums for which state aid are requested by county and district fairs shall conform with the uniform premium list and other requirements set forth in these rules. Fairs requesting state aid for net premiums shall submit to the depart-ment a printed copy of the premium list used at the fair, as required under s. ATCP 160.92 (3)(c).
- (b) The officers of each fair shall mail a copy of the premium list to other associations, societies, or boards conducting a fair in Wisconsin upon request.

(c) Sections ATCP 160.01 through 160.07 and 160.91 shall be published in premium books used by a fair for which state aid is requested.

(3) Entry fees.

- (a) A county or district fair may charge an exhibitor an entry fee. The entry fee may not exceed 10% of the sum of all premiums offered to exhibitors in the same class for which the entry fee is charged. In lieu of an entry fee, a county or district fair may charge stall rents for horses, cattle, sheep, goats, swine, poultry, rabbits or pets.
- (b) Exhibitors in educational and school departments shall not be required to purchase an exhibitor's ticket. Any other exhibitor may be required, if no entry fee is charged, to purchase an exhibitor's season ticket at a price not to exceed that charged for a non-exhibitor's season ticket.

(4) Split Fair Dates.

- (a) For purposes of this subsection, "split fair dates" occur when a fair organization judges exhibits or contests and pays premiums at more than one time or at more than one location during the calendar vear.
- (b) Except as provided under par. (c), the department may not pay state aid for a fair having split dates unless the department gives advance written approval for a split fair. The department may approve split fair dates only if the fair organization justifies the split dates based on extreme hardship. If the department approves split dates, all blue ribbon winners shall repeat their demonstrations or exhibits at the regular Fair dates unless the department grants a hardship exemption. An exhibitor may use audiovisual media, still photography or an educational display to repeat a demonstration or exhibit.
- (c) The department may pay state aid for the following exhibits or contests in a fair having split dates, regardless of whether the department approves those split dates in advance: 1) Clothing Revue. 2) Demonstrations. 3) Favorite Foods Revue. 4) Dogs. 5) Small Animals. 6) Rocketry. 7) Shooting sports. 8) Other exhibits and contests that are similar to those identified in subds. 1.To 7.

ATCP 160.03 EXHIBITION REQUIREMENTS.

A county or district fair shall meet all of the exhibition requirements of this section to be eligible for state premium aid.

- (1) No fair society or other organization sponsoring a county or district fair shall require an exhibitor to become a member of the organization in order to enter an exhibit at the fair, nor shall the sponsoring organization make any deduction from an exhibitor's premium as a donation to the fair society, or require an exhibitor in any other way to make a donation to the society.
- (2) State aid may not be approved for out-of-state

exhibits or for separate classes of local and nonlocal exhibitors. Aid may not be approved for payment of premiums to an exhibitor having an out-ofstate address but claiming Wisconsin residency unless the fair secretary provides the department with an affidavit that the exhibitor's residence is geographically located within the state.

- (3) State aid may be paid only on articles or animals actually on display in an exhibit building or actually shown in the show ring on regular Fair dates unless approval for split fair dates is obtained under s.ATCP 160.02 (4). State aid may not be paid on Dairy Herd Improvement Association records, transportation aid, production contests or other special educational exhibits unless prior approval is obtained under s.ATCP 160.04 (8).
- (4) State aid may not be paid on exhibits removed from the fairgrounds before 4 p.m. of the last day of the fair, or such other later time as may be specified by the fair, without prior approval of the department. Authority for earlier removal may be granted by the department in case of meat animal sales or other special classes, if requested before the beginning of the fair. In other hardship cases, approval may be granted by the local fair. Exhibits in dog obedience and small animal pet classes may be judged during the regular Fair but are not required to remain present during the entire fair. The local fair may prescribe the length of time junior fair exhibitors of horses shall keep their animals on the grounds.

ATCP 160.04 JUNIOR FAIR DIVISION - GENERAL REQUIREMENTS.

- (1) In junior fair division, the department may pay state aid on prizes offered to exhibitors who are under 20 years of age on January 1 or the current fair year. A county or district fair board may establish sub-groups within a junior fair entry class based on the exhibitor's grade level in school. The department may not pay state aid on prizes for club parades, club floats, song contests or a project which is not an exhibit or demonstration at the fair.
- (2) All exhibitors in the junior fair division shall be members of 4-H, FFA, a scouting program, a breed group, or another recognized youth organization under adult leadership that has an education program appropriate to that organization and is approved by the fair board.
- (3) Exhibits in the junior fair shall be the product of the exhibitor's own labor. An exhibit may include a study project, merit project or other special project, a skill area, or a supervised occupational experience in which the exhibitor is regularly enrolled, provided that the fair board approves the project skill area, or supervised occupational experience as an exhibit.
- (4) State aid may not be used to award more than

one premium to any exhibitor in any department in the junior fair division, except that:

- (a) A premium may be awarded to each member of a group that collectively owns and enters a livestock exhibit in departments one to 5 of subch. IV.
- (b) An exhibitor may receive a separate premium for showmanship where authorized under subch. IV.
- (c) An exhibitor may receive more than one premium in a department for which additional premiums are specifically authorized under subch. IV.
- (5) Under subch. IV, within each of the junior fair departments 9, 10, 13 to 16, 18 and 20 to 29, a fair board may establish one or more entry classes for self-determined projects that are related to that department. The fair board may establish class entry criteria, including student grade level criteria. Entry classes are open to 4-H members enrolled in a designated 4-H project or an alternative project that follows 4-H project guidelines, and to members of other youth organizations that do equivalent work and apply equivalent guidelines. Exhibits may be judged using the regular or Danish judging system. For each entry class, a fair board may pay first-place to fourth-place premiums at any of the following levels designated by the board:
 - (a) Premium level one: \$2.00, \$1.75, \$1.50, \$1.25.
 - (b) Premium level 2: \$2.50, \$2.25, \$2.00, \$1.75.
 - (c) Premium level 3: \$3.00, \$2.75, \$2.50, \$2.25.
- (6) If 16 or more animals, items or articles are entered in any junior fair class, the class may be divided into 2 or more approximately equal groups according to weight, age or other identifying characteristic and each group judged as a class.
- (7) Special educational exhibits may be established if the proposal is presented to the Wisconsin association of fairs before October 1 of the year preceding its proposed establishment and the exhibit is approved by the department.
- (8) Within any junior fair department under subch. IV, a county or district fair may establish special classes, where none are specified under subch. IV. Special classes may include classes for grade and crossbred females in the beef, swine, sheep and horse departments. Premiums for special classes created under this subsection shall be equal to premiums for comparable classes established in the same department under subch. IV.

ATCP 160.05 OPEN DIVISION; GENERAL REQUIREMENTS.

(1) The total maximum premiums set forth for all places in any open division livestock class, excluding poultry and rabbits, may be divided into premiums for a greater number of places, but the maximum premium offered for any additional place shall not be higher than the maximum for last place in the class.

(2) All animals in any open division class shall be owned by the exhibitor, except as provided in s. ATCP 160.09.

ATCP 160.06 SENIOR CITIZENS DIVISION; GENERAL REQUIREMENTS.

- (1) The age of exhibitors in the senior citizen division is limited to persons 62 years of age or over.
- (2) Exhibitors in the senior citizen division may not enter identical items or articles in both the senior citizen division and in the corresponding classes of the regular open division.

ATCP 160.07 CLASSES; GENERAL REQUIRE-MENTS.

- (1) Classes may be combined if the number of entries in several single classes is insufficient. If any classes are combined, state aid shall be limited to the maximum total premiums listed for a single class of animals, items or articles in that department.
- (2) (a) Except as provided under par. (b). no county or district fair may receive state aid for premiums awarded for sexually intact male dairy cattle, beef cattle, sheep, goats, swine or horses unless those animals are registered purebreds. Registered purebred status shall be documented by a certificate of registry from the appropriate breed association or society, or by a copy of the application for registration.
 - (b) Paragraph (a) does not apply to dairy cattle exhibited at a county or district fair if a national breed association certifies that those dairy cattle are recorded in that breed association's qualified herd book which records the genealogy of that breed.
- (3) Any animal entered as part of a group class may also be exhibited in a class for individual animals.
- (4) Boars may not be entered as an exhibit in the swine department unless their tusks have been removed.
- (5) The age of an animal, for purposes of determining its entry class under this chapter, shall be determined as of the opening day of the fair.

ATCP 160.91 JUDGING REGULATIONS.

- (1) Judging shall be done at county and district fairs by individuals who are registered with the department and who have knowledge, training or experience in the specific class or classes to be judged as determined by the department. Judging shall be done in accordance with the requirements of s. ATCP 160.92 (3)(a). In no case shall any person who is an officer or director of a fair be eligible to judge exhibits at such fair; nor shall any person interested directly or indirectly in exhibits shown in any department of a fair be eligible to judge articles or animals in that department.
- (2) Each judge at a county or district fair shall be provided with a copy of the fair's premium book or list of entry classes at least 7 days prior to the opening date of the fair.
- (3) No animal or article, irrespective of the number of entries in the class in which it is entered, shall be awarded a higher rating than its merit would entitle it to in comparison to the standard of perfection in the class.
- (4) (a) No state aid will be paid on premiums awarded under the Danish system in any classes except in the junior and educational departments.
 - (b) When classes in the junior and educational departments are judged according to the Danish system, 4 group placings shall be awarded in any class. When there are less than 8 exhibitors in the class, there shall not be more than 2 in the first group, not more than 4 in the first 2 groups and not more than 6 in the first 3 groups. If there are 8 or more entries in the class, there shall not be more than 25% in the first group, not more than 50% in the first 2 groups, and not more than 75% in the first 3 groups.
 - (c) The number of awards in the last group placing may be increased to the extent necessary to give awards to all exhibitors.
- (5) If any class of exhibits at a county or district fair is judged according to the regular system, the judges for that class may give only one first-place, one second-place, one third-place and one fourth-place award in that class.



Animal Health Regulations Egirs and Shows in Wisconsin: 20

Fairs and Shows in Wisconsin: 2021 Season

This is a summary of animal health requirements for fairs, shows and exhibitions only. They are not necessarily the same as requirements for importing animals into Wisconsin or moving them within the state for other purposes. They may change if animal diseases occur in Wisconsin or elsewhere, so you should always check our website or contact us for current information. Ref. s. ATCP 10.87, Wis. Admin. Code

General Requirements for show organizers

All fairs or exhibitions of any length must obtain, review, and keep for five years all required records and test results:

- Exhibitor's name and address
- Animal identification (number, type, description, and, when required, official identification (see requirements for different animals below))
- Documents showing compliance with disease testing and other health requirements
- Livestock premises number, if any, where animals originated
- Documentation showing legal importation to the event (if applicable) and, when required, movement to the event (see requirements for different animals below)
- For swine, a record of any swine transported directly to a slaughtering establishment
- For swine, a record of any swine transported to an animal market where all animals sold at the market sale for that day were shipped directly to a slaughtering establishment

Fairs or exhibitions lasting more than 24 hours must appoint a licensed veterinarian to inspect all animals daily.

Please note: Except in specific circumstances, if an animal already bears an official 840 eartag, that eartag must not be removed and additional official eartags must not be applied. Instead the existing eartag must be read and recorded when a record of that animal is required. (Ref. s. ATCP 10.045, Wis. Admin. Code)

These regulations apply to all fairs and exhibitions, including additional events (like rodeos, shows, or other organized events) that occur in conjunction with the fair.

Diseases

Animals that show evidence of having contagious or infectious diseases may not be commingled (or housed/kept) with other animals at a fair, show, or other exhibition in such a way as to allow disease to spread. Such animals should not attend the fair, show, or exhibition. Animals may be denied entry if they arrive at these events with contagious or infectious diseases, isolated and/or removed if they develop disease after arriving, or be subject to other action as would be necessary to control disease.

Bovine animals with ringworm, mange, warts or scab will be removed from the fair or exhibition premises, unless the veterinarian in charge finds warts or ringworm lesions are incapable of transmitting disease.

Cattle and bison

Cattle from within Wisconsin have no requirements for tests or health documents.

Cattle from outside Wisconsin must:

- Be accompanied by certificate of veterinary inspection (CVI or health certificate)
 documenting official animal identification (ID) and all required tests and certifications
- Have at least one form of official individual ID (including steers)
- Meet all of Wisconsin's normal requirements for import (see https://datcp.wi.gov/Pages/Programs Services/CattleBison.aspx)

Acceptable animal IDs for all cattle from outside Wisconsin

- USDA metal ear tag number that is part of the National Uniform Eartagging System (NUES) (starts with state 2-digit code, also known as "brite" tag); this includes the orange brucellosis vaccination tag
- 15-digit "840" tags (visual or RFID)
- Valid only if applied before March 11, 2015:
 - Manufacturer-coded RFID tag 15-digit number with the first three digits in 900s
 - American ID tag 8 to 12-digit number prefaced with "USA"

Brucellosis requirements for cattle from outside Wisconsin

No cattle from outside Wisconsin are currently required to be brucellosis tested or vaccinated to come to fairs and shows in Wisconsin

Tuberculosis (TB) requirements for cattle from outside Wisconsin

Cattle from Michigan's Modified Accredited Zone (for cattle from Michigan's TB Free Zone, see requirements by state above) also need:

- Import permit
- To originate from a herd that has a negative whole-herd TB test within 12 months before arrival in Wisconsin that includes all animals 1 year and older
- Negative individual TB tests within 60 days before entering Wisconsin
- To return directly to the state of origin after the show, and there must be a statement on the CVI that they will be doing so

Swine

Swine from within Wisconsin need a Wisconsin intrastate certificate of veterinary inspection (CVI or health certificate):

Note: Herd of origin means the herd in which the pigs currently reside, likely the exhibitor's herd. When pigs are purchased from a herd, the herd from which they originate is the herd of origin for the seller. Once the purchased pigs are added into the buyer's herd (even if the buyer's herd only consists of one or just a few animals), the buyer's herd becomes the new herd of origin and that herd must meet testing requirements to move pigs again.

- Stating that the entire herd of origin was inspected on the farm within 30 days before the show and showed no signs of disease.
- Non-terminal Exhibitions: All swine must have a PRRS (Porcine Reproductive and Respiratory Syndrome) and PEDv (Porcine Epidemic Diarrhea virus) test of the herd of origin within 90 days of the exhibition. Include test date, type, and results on the CVI. For swine originating from herds with positive tests, include the herd plan number on the CVI.
- Terminal Exhibitions: No testing requirements.

Note: Terminal Exhibitions are those at which the swine go directly from the fair/show to the slaughtering establishment OR to a slaughter only market sale. If going to a slaughter only market sale, contact the Division of Animal Health fair inspector for required information to collect.

Note: If the fair intends to use a load-out facility, contact the Division of Animal Health in advance to discuss requirements that must be met.

Swine from outside Wisconsin need a certificate of veterinary inspection that includes the following:

- The negative results of the PRRS test from the swine's herd of origin conducted within 90 days prior to movement into Wisconsin including test date, type, and results.
- The negative results of the PEDv test from the swine's herd of origin conducted within 90 days prior to movement into Wisconsin including test date, type, and results.
- A statement that the veterinarian has inspected the entire herd of origin within the past 30 days and that no clinical signs of PRRS and PEDv or any other apparent disease was present at the time of inspection
- Official individual identification (ID)
- If the herd of origin tests positive for PRRS and/or PEDv, contact the Department of Agriculture, Trade and Consumer Protection at 608-224-4872 for options.

Acceptable methods of ID for swine are:

- USDA silver ear tag
- USDA 840 ear tag, either visual or RFID
- Breed association tattoo if the pig is a purebred and the tattoo is registered
- · An ear tag with the premises identification number and a unique identifier
- Ear notch if the pig is a purebred and the notch is registered

Sheep and goats

Note: These rules do not apply to non-domestic sheep and goats. See Exotic Ruminants below.

Sheep and goats from within Wisconsin need:

- If sexually intact, need official individual identification (ID) at any age.
- If not sexually intact, need official individual ID if they are 12 months or older.
- · See below for Official ID options.
- Cannot be under restriction for movement to fairs and shows.
- Sheep and goats that go to a market or slaughter establishment after the fair should have an owner hauler statement to move from the fair to the market/slaughter establishment.

Sheep and goats from outside Wisconsin need:

- Certificate of veterinary inspection (CVI or health certificate) and official individual ID for all animals
- See below for Official ID options.
- See below for additional requirements for goats from Michigan's Tuberculosis Modified Accredited Zone.
- Sheep and goats that go to a market or slaughter establishment after the fair should have an owner hauler statement to move from the fair to the market/slaughter establishment.

Official Identification includes:

- Scrapie eartags (including tags on neckstraps for animals with absent/injured ears or with official tattoos – see DATCP Website*)
- USDA 840 ear tags
- Legible breed tattoos (see DATCP Website* and NOTE below)
- Legible scrapie tattoos (see DATCP Website* and NOTE below)
- Approved microchips (Electronic Identification/EID) There are many requirements that need to be met to use microchips including a requirement for accompanying tattoos. See DATCP Website* and NOTE below.
- NOTE: All sheep and goats that may go through a market or to slaughter and require
 Official Identification must be eartagged with Official ID. Official ID in the form of a tattoo
 or Electronic Implantable Identification (EID) is no longer sufficient when moving through a
 market or going to slaughter.
- **NOTE:** If a Wisconsin origin animal is neutered, less than 12 months of age, and moving through a market after the fair, the market may require Official ID in the form of an ear tag.

Goats from Michigan's Tuberculosis (TB) Modified Accredited Zone also need:

- Import permit
- To originate from a herd that has a negative whole-herd TB test within 12 months before arrival in Wisconsin that includes all animals 1 year and older
- Negative individual TB tests within 60 days before entering Wisconsin
- To return directly to the state of origin after the show, and there must be a statement on the CVI that they will be doing so

Equine

Equine animals from within Wisconsin need documentation of a negative EIA test done within the previous 12 months, which clearly identifies the animal by complete description, digital photographs, or an approved microchip (if a reader is available). No test is needed for nursing foals accompanying negative dams. Documentation may be:

- Official test report VS 10-11, or
- USDA-approved electronic test form, or
- Global Vet Link EIA electronic form, or
- · Certificate of veterinary inspection with the test results listed

Equine animals from outside Wisconsin need:

- Certificate of veterinary inspection (CVI or health certificate) which clearly identifies the animal by complete description, digital photographs, or an approved microchip
- Negative EIA test done within previous 12 months that is reported on the CVI
- No EIA test is needed for nursing foals accompanying negative dams

Equines from Minnesota are exempt from the CVI requirement if:

- · Ownership does not change while the animal is in Wisconsin
- The animal remains in Wisconsin no longer than 7 days
- Proof of a negative EIA test in previous 12 months accompanies the animal

Poultry and waterfowl (Pigeons are not considered poultry for fairs and shows)

Poultry and waterfowl from within Wisconsin need:

- A NPIP certificate stating that the birds originate from a US pullorum-typhoid clean or NPIP affiliate flock and turkeys must test negative for Mycoplasma gallisepticum, or
- A DATCP-issued certificate stating they are from a Wisconsin Tested or Associate Flock and turkeys must test negative for Mycoplasma gallisepticum

or

Individually test sexually mature birds within 90 days before arrival at the show. These birds
also need wing or leg band identification (ID). All birds must test negative for pullorumtyphoid, and turkeys must test negative for Mycoplasma gallisepticum.

Poultry and waterfowl from outside Wisconsin need a certificate of veterinary inspection or equivalent (such as form VS 9-3) that states:

- They originate from a flock classified pullorum-typhoid clean under NPIP or an equivalent state program and turkeys must test negative for *Mycoplasma gallisepticum*, *or*
- If they are sexually mature, that they have tested negative for pullorum-typhoid (and
 Mycoplasma gallisepticum for turkeys) within 90 days before arrival at the show. These birds
 also need wing or leg band ID.

Not required:

Import permit number

Exotic Ruminants

Note: Exotic ruminants are ruminants that are not native to Wisconsin, and are not cervids – for example, Old World camels, yaks, water buffalo, pronghorn antelope, giraffes, and non-domestic sheep and goats. In addition, please contact your county and local municipality for any restrictions.

Exotic ruminants from within Wisconsin have no requirements.

Exotic ruminants from outside Wisconsin must have

- Certificate of veterinary inspection (CVI or health certificate)
- Official individual identification (ID) as required for tuberculosis and brucellosis testing
- Import permit
- Proof written on the CVI that they meet requirements for:
 - o Tuberculosis (TB) negative test required within 60 days before entry
 - Brucellosis negative test required within 30 days before entry

Please call 608-224-4872 beforehand to determine which TB test to use.

South American camelids: Ilamas, alpacas, guanacos, vicuñas

South American camelids from within Wisconsin have no requirements.

South American camelids from outside Wisconsin must have a certificate of veterinary inspection (CVI or health certificate) and official individual identification (ID). Official ID may be:

- Approved USDA ear tag number
- Microchip number
- Breed association registration number
- Breed association tattoo

Requirements are subject to change as conditions warrant. For current information, check https://datcp.wi.gov/Pages/Programs Services/LlamaAlpacaMovement.aspx.

Small animals: Dogs. domestic cats, and other household pets (ferrets, pet birds, rabbits, gerbils. guinea pigs, hamsters, domestic mice and rats) **Note:** For animals that are part of menageries, see also rules below for menageries. Pot-bellied and miniature pigs fall under rules for swine. Dog hybrids, domestic cat hybrids, or exotic small cat species such as servals fall under rules for Exotic small animals. Native wild animals and birds, including raptors, and captive wild animals such as raccoons, opossums, and skunks fall under rules for wild animals.

Dogs from within Wisconsin that are 5 months or older need proof of current rabies vaccination.

Cats and other household pets from within Wisconsin have no requirements.

Dogs and cats from outside Wisconsin that are 5 months or older need to be vaccinated for rabies by a licensed veterinarian, and regardless of age, need certificates of veterinary inspection (CVIs or health certificates) stating the age of the animal and for animals 5 months and older the date of last rabies vaccination and revaccination due date.

Other household pets from outside Wisconsin need certificates of veterinary inspection (CVIs or health certificates) but have no testing or vaccination requirements.

Small animals from other nations need to meet requirements of the U.S. Department of Agriculture (608-662-0600) and Centers for Disease Control (1-800-232-4636).

Exotic small animals (any species not covered by "small animals" above), exotic large animals, and other wild animals

Note: Local jurisdictions may have requirements beyond the state requirements listed here.

Animals from within Wisconsin do not have any requirements as long as they are legally possessed in Wisconsin.

Animals from outside Wisconsin generally have no testing or vaccination requirements, but do need:

- Certificate of veterinary inspection (CVI or health certificate)
- Import permit number

Note: Some animals may not be brought to Wisconsin. These are North American prairie dogs and the following African species: tree squirrels, rope squirrels, dormice, Gambian giant pouched rats, brush-tailed porcupines and striped mice. Some animals may require permits from the Wisconsin Department of Natural Resources. See http://dnr.wi.gov.

Circus, rodeo, racing and menagerie animals

Note: Local jurisdictions may have requirements beyond the state requirements listed here.

Animals from within Wisconsin must meet vaccination and testing requirements for their species. See these requirements earlier in this document.

Animals from outside Wisconsin need certificates of veterinary inspection (CVIs or health certificates) and vaccinations, identification, and tests required for their species. See these requirements earlier in this document.

They also need import permit numbers if they are:

- · Circuses and individual circus acts
- Rodeo stock other than individual participants' horses
- Multi-species menageries (defined as any animals kept in a collection primarily for purposes of exhibition or competition)
- Petting zoos

They do not need import permit numbers if they are:

- Rodeo horses owned by individual participants
- · Single-species groups

Note: Some animals may not be brought to Wisconsin. These are North American prairie dogs and the following African species: tree squirrels, rope squirrels, dormice, Gambian giant pouched rats, brush-tailed porcupines and striped mice. Some animals may require permits from the Department of Natural Resources. See https://dnr.wi.gov/topic/wildlifehabitat/captive.html

Guidelines for housing and managing animals

The State Veterinarian recommends that exhibitors:

- Vaccinate breeding cattle against bovine viral diarrhea (BVD) at least 30 days before the event
- Test cattle for BVD-PI by immunoperoxidase test, and bring them to shows only if they test negative
- Test cattle for Johne's disease by ELISA test, and bring them to shows only if they test negative
- Clean and disinfect vehicles used to transport animals to and from the show, and vehicles
 used on the grounds before, during, and after the show
- Isolate exhibited animals returning to their farms or animals purchased at the show for 21 days before mingling them with other stock

The State Veterinarian recommends that show organizers:

- House cattle separately from South American camelids and other exotic ruminants
- House cattle separately from small ruminants, especially sheep
- House ostriches, emus, rheas and cassowaries separately from domestic poultry
- House swine separately from any other mammals
- Include a space for the premises registration code on livestock entry forms
- Provide hand-washing stations near all livestock facilities
- Provide individual watering and feeding troughs rather than common ones

DEPT. 1—JUNIOR DAIRY CATTLE

Superintendents: Kim Drews & Emily Strahota

<u>Don't forget to sign up for Showmanship if you are</u> interested (See Class at the end of this Department).

Spring Calf is one whose date of birth is on or after March 1 of the exhibit year. The calf must be at least 90 days of age at the fair.

Winter Calf is one whose date of birth is between December 1 of the year preceding the exhibit year and February 28 or 29 of the exhibit year.

Fall Calf is one whose date of birth is between September 1 and November 30 of the year preceding the exhibit year.

Summer Yearling is one whose date of birth is between June 1 and August 31 of the year preceding the exhibit year.

Spring Yearling is one whose date of birth is between March 1 and May 31 of the year preceding the exhibit year.

Winter Yearling is one whose date of birth is between December 1 of the second year preceding the exhibit year and February 28 or 29 of the year preceding the exhibit year.

Fall Yearling is one whose date of birth is between September 1 and November 30 of the second year preceding the exhibit year.

- A. Green Lake County is a non-baiting obedience training program.
- B. All dogs must have distemper; hepatitis lepto spervus (DHM) and parvovirus shots within 1 year of show date and rabies shot must be current. Please bring vaccination records to the Fair on the day of the show. If there is no proof of vaccinations, the dog cannot be shown.
- C. Dogs must be at least 6 months of age to show.
- D. No prong collars will be permitted in the show, unless approved by leaders.
- E. Females in season will be allowed to show at the County Fair. Handler and dog in season will be put to the end so not to upset other dogs.

- F. Each member must have trained the dog which he enters.
- G. All classes will be judged under current American Kennel Club Rules (adapted to 4-H).
- H. More advanced handlers will be allowed to train and handle more than one dog if requested at the beginning of the session. Only ONE animal may be entered in a particular obedience class, and only ONE obedience class may be entered with each dog.
- Any dog entered in any class may repeat that class a second year or more if he/she did not receive a qualifying score at the dog show the previous year. A qualifying score is 170.
- J. All youth must attend County Dog Obedience classes with their dog to be able to show in Division J of the County Dog Show at the Fair. Parents are allowed to bring dog to class if child has an explained and pre-approved absence.
- K. More than three unexplained absences from regular weekly training classes may result in the elimination of the dog and handler from showing at the fair at the discretion of the Superintendents.
- L. The instructor reserves the right to drop any dog, if member appears too small or young to handle the dog. He/she will be asked to postpone training for another year. Some 9 to 11 year old handlers who have nervous or large dogs may be in this group.
- M. No dog will be substituted for one already in the Class unless there are special circumstances.
- N. All Dog Show exhibitors are asked to bring a poster to the Fair that includes a photo of their dog, name, breed, and any other pertinent information the exhibitor would like to include. The posters will be displayed during the Fair, along with the ribbon awarded. This poster will not be judged.

Dog Agility is a dog sport in which a handler directs a dog through an obstacle course in a race for both time and accuracy. Dogs run on and off leash with no food or toys as incentives and the handler can touch neither dog nor obstacles laid out by a judge in a design of his or her own choosing in an area of a specified size. The surface may be of sand, grass, dirt, rubber, or special matting. Depending on type of competition, the obstacles may be marked with numbers indicating the order in which they must be completed. Small and medium sized breed dogs under the age of one (1) should not participate and large breed dogs under the age of 1 -1/2 should not participate for their joints are not strong enough at those ages. Handler can enter no more than two (2) dogs per class.

Agility Rules and Information – On Leash:

Course consists of 10-15 obstacles. Course to be completed in 75 seconds. Before competition begins, handlers will be allowed to walk through the course to become familiar with the course. Handlers can ask any questions they may have at that time. No food or toys are permitted during competition. Handlers may be on either side of the dog while running the course. Flat collars are required for all dogs. No pinch or choke collars are allowed in the agility course.

All photos may be color or black and white.

Photos must be taken by the exhibitor, since the prior year's Fair.

Do NOT caption individual photos. The poster may be titled if a title would enhance or clarify the display, i.e. "A Rare, Quiet Moment" or "A Field of Beauty," NOT "Two pictures, people." Photos should not have the day/date stamp on them. Cameras have an option to turn this feature off, or the number can sometimes be cropped off the photo.

All photography exhibits must be mounted to an 11x11 square of white poster board. Size exception: panoramic groupings, family tree posters, and photo essays which may be as large as necessary, up to 21" in width. When one entry calls for two or more photos, both (or all) are mounted on the same poster board. Use double stick tape or rubber cement for mounting the photos. DO NOT use a glue stick – the photos eventually fall off.

Mount the entry tag on the front of the board so that it DOES NOT HANG BEYOND THE EDGES OF THE POSTER, USING STAPLES OR TAPE. DO NOT USE THE STRING. When possible, also leave space (approximately 1-1/2"x6") for the ribbon. Arrange photos as needed to allow for the above; photos need not be centered.

Sizes of photos for the 2-photo groups may be any dimension up to 5x7" with a minimum of 4" on the narrowest dimension. Enlargements can be any dimension up to 8.5x11", with a minimum of 5" on the narrowest dimension.

Cropping to non-standard sizes (by computer or by hand) is strongly encouraged whenever they would improve the photo composition

(removing distractions from the background, for example).

Photography will be evaluated on the basis of technical quality, composition, and storytelling ability. Matting, colored paper behind the photos, scrapbooking decorations, etc. are not encouraged; the judge will judge ONLY the photographs. Framed photographs will not be accepted.

- A. Any exhibitor over the age of 18 as of January 1st will be allowed to enter in the Open Division.
- B. Registered and grade cattle will be placed in classes together.
- C. Open Class exhibitor's milk will be placed in the Fair's bulk tank with proceeds going to the Green Lake County Dairy Premium Bonus Committee.
- D. Any cow treated with antibiotics must make special milking arrangements with the dairy superintendent. Any person who puts treated

milk in the bulk tank will be responsible for all the milk in the tank. Fair checks and health records will be withheld until payment for the milk is made.

- E. All Open Class Exhibitors must attend the Mandatory Meeting or speak to a Dairy Super-intendent at least one week prior to the Fair.
- F. No person may exhibit more than three (3) animals.

Spring Calf: is one whose date of birth is on or after March 1 of the exhibit year. The calf must be at least 90 days of age at

the fair.

Winter Calf: is one whose date of birth is between December 1 of the year preceding the exhibit year and February 28 or 29 of the exhibit year.

29 of the year preceding the exhibit year.

Fall Yearling: is one whose birth is between September 1 and November 30 of the second year preceding the exhibit year.

Cow 2 to 3 years old: is one whose birth is between September 1 of the third year preceding the exhibit year and August 31

of the second year preceding the exhibit year, and shall include yearlings which have freshened.

Cow 3 to 4 years old: is one whose birth is between September 1 of the fourth year preceding the exhibit year and August 31

of the third year preceding the exhibit year.

Cow 4 to 5 years old: is one whose birth is between September 1 of the fifth year preceding the exhibit year and August 31 of

the fourth year preceding the exhibit year.

Cow 5 years old and over: is one whose date of birth is between September 1 of the sixth year preceding the exhibit year and

August 31 of the fifth year preceding the exhibit year.

Dry Cow: Is a 3 year old or over that has milked 280 days or more since the last fair season

- A. All dogs must have distemper, hepatitis lepto spervus (DHM) and parvo virus shots within 1 year of show date and rabies shot must be current. Please bring vaccination records to the fair on the day of the show. If there is no proof of vaccinations, the dog cannot be shown.
- B. Dogs must be at least 6 months of age to show.
- C. No prong collars will be permitted in the show.
- D. Females in season will be allowed to show at the County Fair. Handler and dog in season will be put to the end so not to upset other dogs.
- E. Each member must have trained the dog which he enters.

- F. All classes will be judged under current American Kennel Club Rules (adapted to 4-H).
- G. More advanced handlers will be allowed to train and handle more than one dog if requested at the beginning of the session. Only ONE animal may be entered in a particular obedience class, and only ONE obedience class may be entered with each dog.
- H. Any dog entered in any class or higher may repeat that class a second year or more if he/ she did not receive a qualifying score at the dog show the previous year. A qualifying score is 170.
- I. No dog will be substituted for one already in the class.
- J. All Dog Show exhibitors are asked to bring a poster that includes a photo of their dog, name, breed, and any other pertinent information the exhibitor would like to include. The posters will be displayed during the Fair, along with the ribbon awarded. The posters will not be judged.

Dogs run on and off-leash with no food or toys as incentives, and the handler can touch neither dog nor obstacles. Consequently the handler's controls are limited to voice, movement, and various body signals, requiring exceptional

training of the animal and coordination of the handler. In its simplest form, an agility course consists of a set of standard obstacles laid out by a judge in a design of his or her own choosing in an area of a specified size. The surface may be of grass, dirt, rubber, or special matting. Depending on the type of competition, the obstacles may be marked with numbers indicating the order in which they must be completed.

When one entry calls for two more photos, both (or all) are mounted on the same poster board. Use double stick tape or

rubber cement for mounting the photos. Do NOT use a glue stick – the photos eventually fall off. Mount the entry tag on the front of the board so that it DOES NOT HANG BEYOND THE EDGES OF THE POSTER, USING STAPLES OR TAPE. DO NOT USE THE STRING. When possible, also leave space (approximately 1-1/2x6") for the ribbon. Arrange photos as needed to allow for the above; photos need not be centered.

Sizes of photos for the 2-photo groups may be any dimension up to 5x7" with a minimum of 4" on the narrowest dimension. Enlargements can be any dimension up to 8.5x11", with a minimum of 5" on the narrowest dimension. Cropping to nonstandard sizes (by hand or by computer) is strongly encouraged.

Photography will be evaluated on the basis of technical quality and composition. Matting, colored paper behind the photos, scrapbooking decorations, etc. are not encouraged; the judge will judge ONLY the photographs. Framed photographs will not be accepted.
