

2023 Green Lake Fairest of the Fair Expectations and Agreement

1. Contestant(s) must meet all requirements outlined on application.
2. Contestant(s) must make individual arrangements or have the ability to make individual arrangements for transportation adequate to meet position responsibilities and essential position functions.
3. Contestant(s) must be a resident of Green Lake County or enrolled in a Green Lake County or Ripon youth organization approved by the Fair.
4. Contestant(s) must be available to attend five (5) large community events (some examples given below)
 - a. HarvestFest - Green Lake
 - b. June Dairy Days - Markesan
 - c. Memorial Day/4th of July Events - County Wide
 - d. Focus on the Farm and Ripon FFA Breakfast
 - e. Christmas in the Park - Berlin
 - f. Trunk or Treat - Berlin/Green Lake
5. Contestant(s) must be able to attend five (5) small community events (examples below)
 - a. Farmers Markets, Princeton Flea Market, farmers markets, fireworks, Concert in the Park, Triathlon/Marathon/5K events, youth pedal pulls, local fire department fundraisers, library readings, other county fairs, classroom visits OR any other community event within the county with approval of committee.
6. Contestant(s) MUST attend all four (4) days of the 2023 Green Lake County Fair (Aug. 3-6).
7. Contestant(s) are strongly encouraged to attend the 2023 Fairest Reunion at State Fair.
8. The contestant(s) agrees that the time, method, and manner of judging shall be solely within the discretion of the rules and regulations set forth by the Green Lake County Fair and the Wisconsin Association of Fairs and that the decision of the judges shall be final.
9. If I am named as the Green Lake County Fairest of the Fair, and for any reason do not fulfill the duties of this position for the entire one year term, I will forfeit all scholarship monies and other prizes that are awarded with the position. All the scholarship monies and other prizes will be returned to the Green Lake County Fair.
10. Contestants will be required to dress in business or professional attire, accompanied by the sash and crown, as well as act in a business professional manner, while on duty promoting and representing the Green Lake County Fair. Dresses should be knee length, no plunging necklines, shoulders covered. Fair dress code must be appropriate for events attending. (i.e. may wear slacks, boots and dress shirt to livestock events).
11. If I am named as the 2023 Green Lake County Fairest of the Fair, I will compete in the Wisconsin State Fairest of the Fairs competition January 7-10, 2024.

- a. Gather/provide donated auction basket items that symbolize Green Lake County and the Green Lake County Fair for the Fairest Basket Auction that takes place at the Wisconsin Association of Fairs Convention. Along with a scrapbook of my year long memories of being the Green Lake County Fairest of the Fair.
12. Create Fairest of the Fair display (tri-fold poster) to be used at events and for promotion at the Green Lake County Fair
13. If I am named as the Green Lake County Fairest of the Fair I will NOT consume alcohol, illegal drugs or use tobacco products while on official duty representing the Green Lake County Fair.
14. The individual(s) selected as Green Lake County Fairest of the Fair will not be eligible to compete in future Green Lake County Fairest of the Fair competitions within the same division.
15. Contestant(s) must contribute to Fairest of the Fair/Fair Ambassador social media accounts regularly.
16. Applicants should have appreciation for the Fair but are not required to have exhibited at the Fair.
